## Member Agencies

Norfolk Advocates for Children is a public and private partnership with a list of over 50 member agencies. Their representatives provide resources and services to ensure the NAC reaches its goals.

Currently, the NAC member agencies include community social service agencies, local hospitals, state agencies, mental health agencies and medical professionals, as well as, all police departments within Norfolk County.

# Norfolk Advocates for Children

The Norfolk Advocates for Children (NAC) is a partnership of public and private agencies that work together collaboratively to help child victims of physical and sexual abuse, child neglect, child witness to violence, commercial sexual exploitation (CSEC), and individuals with disabilities and their supportive families.

The NAC offers an immediate response to cases of child abuse and coordinates direct care to these children and families using a child-friendly, culturally sensitive and multidisciplinary approach.

The NAC also provides community education, training and advocacy on issues related to child abuse prevention and treatment.

## Goals of Norfolk Advocates for Children:

- To minimize the number of times that abused children are interviewed.
- To provide a swift and sensitive response to child abuse victims and their families.
- To facilitate coordination and collaboration between community agencies.
- To ensure that comprehensive services are available to meet the needs of child abuse victims and their families in Norfolk County.
